Functional Behavior Assessment and Behavior Intervention Planning

Join us on Wednesday, June 6th, 2012 for a Keynote presentation by Dr. Mandy Rispoli:



Dr. Rispoli is an Assistant Professor of Special Education at Texas A & M University and a Board Certified Behavior Analyst – Doctoral level (BCBA-D). Dr. Rispoli is also the co-director of the Intervention Clinic, part of the Autism Assessment Intervention and Research Clinic in Bryan, Texas. To date, Dr. Rispoli has published over 50 peer-reviewed research articles and two book chapters concerning the education of children with autism and developmental disabilities. Dr. Rispoli's primary research focus pertains to functional assessment and function-based antecedent interventions for challenging behavior in children with autism spectrum disorder. Her work in this area explores the role of variables that may alter a child's motivation to engage in challenging behaviors during behavioral assessments and interventions. Dr. Rispoli serves on the editorial review board for Assessment for Effective Intervention, Behavior Modification, and Journal of Developmental and Physical Disabilities. Keynote Session:

Demystifying the Functional Behavior Assessment Process

A recent study reported that 94% percent of surveyed individuals with ASD engaged in some form of challenging behavior (Matson, Wilkin, & Macken, 2009). Without appropriate intervention and supports, these behaviors can lead to negative outcomes including loss of instructional time, social isolation, and placement in restrictive settings. The functional behavior assessment process is designed to lay the foundation for building effective behavioral interventions to prevent and reduce challenging behaviors. This presentation will review recent trends and issues related to functional behavior assessments for persons with ASD, provide a detailed and engaging break down of the components of a functional behavior assessment, and explore applications of functional behavior assessments in the real world.

Breakout Session:

When Clicking Your Heels Doesn't Work: Practical strategies for building usable and effective behavior intervention plans

The Individuals with Disabilities Education Act requires that behavior intervention plans be developed for students who engage in severe challenging behavior. However, many behavior intervention plans suffer from the "file drawer syndrome" in which they are filed away and not implemented correctly. This session will present step by step procedures for developing effective and usable behavior intervention plans for students of all ages with autism spectrum disorder. In addition, tips for implementing evidence-based interventions for challenging behavior will be presented.

This day will also feature afternoon Breakout presentations from regional speakers and school-based teams.





Have You Been Told That Your Son or Daughter, Who Has a Disability, is not Allowed to Inherit Money? by J. Doug Sunseri, Attorney-at-Law

Often, parents and family members are left with the disheartening prospect as to how their special needs son/daughter or family member with a disability will be supported after they die.

Normally, an inheritance will interrupt his or her SSI and Medicaid.

Therefore, someone who has a disability cannot inherit more than \$2,000 because it will interrupt his or her government benefits.



There is an easy way around this problem. You can leave money for your son or daughter, without interfering with the public benefits. This concern can be addressed by a Supplemental Needs Trust (also known as Special Needs Trust). This Trust will allow a family member with a disability to retain governmental benefits and protect assets acquired throughout a lifetime.

A Supplemental Needs Trust may be a stand alone document or it can be a part of a Last Will and Testament. A Supplemental Needs Trust enables a person with a physical or mental disability, or an individual with a chronic or acquired illness, to hold in Trust, an unlimited amount of assets for his or her benefit without jeopardizing entitlement for Social Security Income (SSI), Medicaid, vocational rehabilitation, subsidized housing, waiver services and other government benefits.

A Supplemental Needs Trust provides for supplemental and extra care over and above the support which is provided by government to improve the quality of life. If Medicaid won't pay for certain medical care or treatments, the Trust can step in and provide those. The primary restriction of a Supplemental Needs Trust is it cannot provide a benefit for food or housing. Supplemental Needs Trust may pay for insurance, rehabilitation, job training,

education, maintenance, equipment, transportation, recreation, eyeglasses, health club and I-Phone/Blackberry.

Further, Supplemental Needs Trust allows the Trustee to allocate funds on behalf of the beneficiary for electronic equipment, companion/support services, athletic training and sports, travel/vacations and programs to promote independence and enhance self-esteem.

A Supplemental Needs Trust can be established at any time before the beneficiary's 65th birthday. It is common to create a Supplemental Needs Trust early in a child's life as a long term vehicle for holding assets to benefit the family member with a disability. This particularly applies to parents who wish to leave funds for a child's benefit after the parents' death. The cost of the creation of the Trust is tax deductible.

A family or person seeking to create a Supplemental Needs Trust is advised to utilize the services of an attorney who is proficient in disability issues. A Supplemental Needs Trust can very easily be invaded by government if the Trust is invalidated due to the lack of proper language throughout the Trust. The Best in Travel Apps! With summer time quickly approaching and school winding down, many of us will embark upon our much anticipated travel



April is Autism Awareness Month

What is Autism? Autism is a complex developmental disability that typically appears during the first three years of life and affects a person's ability to communicate and interact with others. Autism is defined by a certain set of behaviors and is a "spectrum disorder" that affects individuals differently and to varying degrees. There is no known single cause of autism and it can be found in combination with other disabilities.

Know the Signs: Early Identification Can Change Lives

Autism is treatable. Children do not "outgrow" autism, but studies show that early diagnosis and intervention lead to significantly improved outcomes.

Here are some signs to look for in the children in your life:

- Lack of or delay in spoken language
- Repetitive use of language and/or motor mannerisms (e.g., hand-flapping, twirling objects)
- Little or no eye contact
- Lack of interest in peer relationships
- Lack of spontaneous or make-believe play
- Persistent fixation on parts of objects

A Note From Delery Rice, Regional LaCAN Leader:

This year's legislative session is underway. LaCAN has two current issues we are asking our legislators to consider and members to advocate for this session. The first is that people with developmental disabilities need waiver services. We are asking our legislators to appropriate funds for these services. Waiver services are more cost effective and afford individuals a better quality of life than institutional settings. Services and supports provided through home and community-based waivers allow individuals with developmental disabilities to live independently in their own home or with their families in the community. The second is a bill already filed, Senate Bill 227 (SB227). This allows for what LaCAN is referring to as "Let the Money Follow the Person". Louisiana has the highest number of people in ICF/DD (Intermediate Care Facility/Developmental Disabilities) per capita in the country. Louisiana has made significant progress in recent years in reducing the number of public ICF/DD facilities and the total census in these facilities. However, this same reduction has not occurred in private ICF/DDs. People with disabilities can live more independently and have a better quality of life through the use of home and community-based waiver services. Home and community-based services are national best practice. Providers choosing to convert will be paid the fair market value to close each of their ICF/DD beds. Approximately 724 of the 3,750 people in Louisiana's private ICF/DD are on the seven year waiting list for waiver services.

Finally, mark your calendars for our "Yellow Shirt Week". "Yellow Shirt Days" are marked for April 16th and 17th. I will send out further information as I receive it.

Students with Significant Disabilities Deserve Choices and Services in Charter Schools

Facts First

- Students with significant disabilities are not served by most Charter Schools.
- Changes to school systems being responsible for students based on where they live have increased the segregation and limited options of students with disabilities.

What Legislators Can Do:

Ensure all students have equal access to and services in quality schools.

Why Do This?

Changes to the traditional structure and responsibilities of Local Education Agencies have led to students with disabilities being more segregated.

There are concerns that resources designated for services to students with disabilities are being unfairly distributed to schools who are not serving students with more significant disabilities. School districts serving all students are finding it increasingly difficult with smaller portions of resources.

To be the most effective LaTEACH member during session, we have some tips that will help you take advantage of every opportunity to take a stand and let your voices be heard on issues that matter to you and students in Louisiana.

- **Tip 1:** Check your email at least daily. Make sure to check your spam folder too.
- Tip 2: Make sure to read the entire email.
- **Tip 3**: Take note of the bills' numbers and if it is a Senate bill or House bill.
- **Tip 4:** Look for where the bill is in the process.
- **Tip 5:** Never assume other LaTEACH members are contacting policymakers so you don't have to.
- Tip 6: Use sample letters as a guide.
- **Tip 7:** Know your Senator's and Representative's contact information.
- **Tip 8:** Make sure to confirm your action to LaTEACH.
- Tip 9: Add LaTEACH to your Facebook account.
- **Tip 10:** Identify four family members or friends who will join you in LaTEACH efforts.
