A Message from the

Executive Director



Well, 2012 has been an action packed year. Although FHF of SELA has gone through some growing pains it has been a good thing. We outgrew our little cottage on Franklin Avenue and moved to New Orleans East in September. FHF of SELA went from having six employees during the summer to now having nine.

So much has happened in the disability world this year also. Families continue to wait for services and are fearful their wait will even be longer due to the financial crisis in Louisiana. The state fully implemented Resource Allocation to help cut the cost of providing waiver services and to alleviate some funding to provide services for more individuals. However, changes have been made to the Flexible Family Fund (Cash Subsidy) and 55 individuals in Louisiana lost this service due to these changes.

Bayou Health now administers Medicaid services (except for individuals on waivers). Magellan now oversees medical care for Behavioral Health. And the state and OCDD is embarking on a system transformation, which we at FHF of SELA will tell you more about in the coming months.

FHF of SELA held their first official fundraising event, the *Turkey Bowl*, in November and we were very pleased with the turnout. We plan to make this an annual event but next year we will plan it for a Sunday when the Saints are out of town, on their bye week or when they play during the week, because we want to have all of the *Who Dat* fans join us for food and fun at Rock 'N' Bowl! We are also planning an event for the spring, so keep an eye out for the time, date and place in our next newsletter. It will be a wonderful opportunity for families to meet other families and have a good time.

We are VERY excited about our newest endeavor, The Prism Project of GNO. A great deal of this newsletter is dedicated to the program and we invite anyone who has children between the ages of 6 and 14, with AND without disabilities, to consider being a part of this wonderful opportunity.

FHF of SELA is also seeking funding to hold a comprehensive Career Symposium for our youth ages 16-22 that are transitioning out of high school. This will be a two day event and is designed to prepare a student who will be exiting high school and entering the real world – and a job. We will have more information for you in future newsletters.

Changes are taking place in Social Security and there are now over 200 disabilities that will be "fast-tracked" in order to provide individuals with disabilities the assistance they need.

There is also a new government act in the midst of all the changes, The Family Opportunity Act. This will play out in the coming year and we will continue to advocate for the best possible services that can be provided to individuals with disabilities.

Please go through the entire newsletter and see what we have planned for the next three months. We have education workshops, both in person and online, the annual LaCAN/LaTEACH roundtable (ANYONE that is waiting for any type of service should attend this to meet with and talk to the legislators who make the decisions that affect their lives), a workshop on caregiver stress, a workshop on parents' rights and responsibilities who are receiving waiver services or respite services through MHSD.

Another year comes to an end. I send my best wishes to everyone for a joyful and blessed holiday season. And all of us at FHF of SELA look forward to serving you and your family in 2013!

The Prism Project of Greater NOLA: Roux-Roux Productions (TPP of GNO) is a performing arts recreational activity for children with special needs ages 6—14 in Orleans, Plaquemines and St. Bernard Parishes. The program originates from an already established and successful program in Muncie, Indiana at Ball State University. TPP of GNO will help children with disabilities engage and develop socially as well as learn performing arts skills. The program intends to close the gap in recreational activities for children with disabilities by providing children with special needs the opportunity to express themselves and engage with others. It is through this method that they will gain self-confidence, self-esteem, experiences and friendships.

TPP of GNO will focus on teaching children with special needs dance, music and theater with the goal of producing a performance at the end of the program. This program will be inspired and written by the participants, with the help of a highly-skilled Scriptwriter.

We at FHF of SELA are incredibly excited to offer a recreational program for children with special needs in the Greater New Orleans area. TPP of GNO is a partnership with the University of New Orleans, Ball State University and the New Orleans Recreational Development Commission (NORDC). NORDC will be providing us with the space for the rehearsals, which will take place at the Behrman Center: 2529 General Meyer Ave, New Orleans, LA. The staff will consist of a program coordinator, three directors (one for Music, one for Dance and one for Theater), a Scriptwriter, two Behaviorists, and volunteers studying special education, music, theater and/or dance.

Finally, TPP of GNO would not be in existence without the generous support and financial donation from The Davis-Molony Foundation as well as private donors, and to them we say thank you from the bottom of our hearts.

End of the Year Update from the La Family to Family Health Information Center

Season's Greetings from the La Family to Family Health Information Center, your resource for health, health care financing, Medicaid and insurance questions for families of children and youth with special health care needs and disabilities (CYSHCN), ages 0-26.

Bayou Health and Waiver Recipients

To date, Medicaid Waiver Recipients are NOT included in the Bayou Health, Managed Care program. This could change sometime in the future; however, we have no indication if or when it could change from the State. For now, Waiver recipients will remain on "Legacy" Medicaid.

Prescription Limits through Legacy Medicaid

There is a 4 prescription limit through Legacy Medicaid, HOWEVER, that limit can be overridden by the pharmacy if the doctor correctly indicates for an override on the prescription. If you are denied a prescription, you and/or your pharmacist should call the physician to discuss if an override is appropriate.

Pharmacy Benefits and Bayou Health

Three of the 5 Bayou Health Plans began providing pharmacy benefits. Louisiana Healthcare Connections, LaCare and Amerigroup plan members began getting their prescriptions through their plans on November 1st. If you have Medicaid through Community Health Solutions or United Health Care you will still receive their prescriptions through "Legacy" Medicaid. Medicaid Managed Care and Children with Special Health Care Needs

Do you have a child with complex medical needs and need to choose a Bayou Health Plan? These bulletins explain the differences in plans on things like referral and pre-authorization policies, and EPSDT. How Will Changes to the DSM-5 Effect Diagnosis of CYSHCN?

The new Diagnostic and Statistical Manual of Mental Disorders is almost complete and new criteria change the way doctors diagnose things like Autism, Asperger's and other disorders. Social Security Administration Announces 200 New Diagnoses which Qualify for Fast Track Disability Approval SSA allows for certain disability diagnoses to be "fast track" diagnoses for disability benefits approval. They are called "Compassionate Allowance Conditions." By definition, these conditions are so severe that SSA does not need to fully develop the applicant's work history to make a decision. ADA AND TRANSITION Q&A

Parents and advocates agree that high school students with disabilities should learn about civil rights laws, such as the Americans with Disabilities Act (ADA) and Section 504 of the Rehabilitation Act, that protect them from discrimination. It is often hard, however, to interest teenagers in learning about these laws. One way to show students the relevance of disability rights is to look at how these laws affect activities in which students have a genuine interest.

Individualized Transition Plans (ITPs) and Individualized Education Plans (IEPs) are required by law to help students with disabilities prepare for school, work and adult life after high school. Transition Plans identify key categories of life activities such as "Jobs and Job Training," "Post Secondary Education & Training," "Community Participation," "Recreation and Leisure," and "Home Living." Students focus on building skills that they need in these areas. Learning about the ADA by applying it to real-life situations can help make the ADA more understandable, show its relevance, and help students to develop self advocacy skills they will need.


